Dear Mr. Pearson,

I have your letter of June 6th in reference to the return to Canada of your son, Lieutenant L. P. Pearson.

The need of men is so urgent that we have had to reduce to the minimum the number returned to Canada, and the circumstances in which a man can be permitted to return must be very grave indeed. I am very sorry not to be able to accede to the request of a family which has given so generously to the Cause, and whose sons have done so splendidly, but unfortunately my personal feelings in the matter cannot be allowed to interfere with my duty.

I hope that the relief from anxiety which Mrs. Pearson will feel while her sons are in this country will result in her being restored to health.





matter up with the War Office.



In reply to your 6-P-375 of

C.A.M.C., #4 Canadian General Hospital, I beg to
submit the following report,--

Private Lester Pearson has completed
his second year in the Arts Course at the University
of Toronto. He enlisted with #4 Canadian General
Hospital in March, 1915 and has been serving in the
Quartermasters' Department of that unit since that date.

At all times his work has been
of a most thorough, conscientious, reliable character.
He would have received promotion long before this time
had the opportunity presented itself but the health
of the men especially in the Quartermaster' Dept. has
been uniformly so good that we have had few vacancies
to fill. He is thoroughly qualified and competent
to assume commissioned rank in the Canadian service
both by education and social standing, but it would be
necessary for him to undergo a course of training.

I can unhesitatingly recommend
him for promotion to commissioned rank.

Dear Sir Sam,-

I have a second son Lester, with the University Base Hospital No 4, at Saloniki. He was a second year student at Victoria College when he enlisted in April 1915. He has asked me several times to write you re a commission in the Army Service Corps or if the need be greater in the Artillery. He prefers the former because he has been in the Stores Department of the hospital in Greece. I have thought that when all my family, viz. three sons have gone to the front, and all went at once as privates. I might fairly ask that after service for eighteen months they might receive promotion. He writes me that a number of his student friends from the Hospital have returned to England to train for Commissions and today he had gone so far as to cable me to intercede in his behalf. He is a son than whom there is no better and I should greatly appreciate your consideration of this request as in the case of my eldest Marmaduke with the 25th Battery at the front.

Does it not seem to you eminently fair that his ambition to do a bigger "bit" than he had been doing should be gratified.
