LABORATORY REPORT.

Body of a well developed well nourished man in the right frontal region a several irregular radiating scars which are healed. Beneath this is a circular opening of scar about 3cm in diameter and with evenly trimmed edges. From this opening brain substance protrudes and is adherent to the dura mater and scar tissue. The brain substance is also adherent to the dura mater in adjacent parts of the temporal lobe. The cistern spaces contain some blood clot; the cerebral spinal fluid is cloudy and the base of brain is covered with a purulent exudate. Brain is injured by a large tract entering the upper part of right frontal lobe passing downward and medially under the larger ventricle destroying the basal ganglia, exdate, and lenticular nucleus and ending in the anterior part of the dorsal horn. This point just beneath the floor of lateral ventricle is a steel F. Body about 1cm. in diameter. Rest of organs normal
