The above named man was admitted to Military Hospital, Kimmel Park on 22/10/18 suffering from broncho-pneumonia, complaining of severe aching pains all over, of hard dry cough which caused considerable pain in his chest.

On examination large moist rales were audible all over front part of chest; tactile fremitus increased over bases of both lungs with dulness on percussion.

Fine crepitations audible over these regions up to the fourth intercostal space-breathing shallow and laboured-respiration 35, pulse weak and small-96-temperature 100.4 slightly cyanosed. Heart tonics and stimulants were prescribed but the following day the symptoms became much more grave-respiration increased to 50-temperature rose to 103.6, pulse more rapid and smaller.

From this date he gradually became more cyanosed-vomiting setain-nutrient enemata had to be administered. He died of heart failure at 0330 on 27/10/18.

The cause of death was broncho-pneumonia, attributable to exposure to infection while on military service during present war.
