LIST OF DISCHARGE POLICIES

1. Discharge of a member from the organization shall be the responsibility of the Board of Directors. 4. A member who has been discharged from the organization shall not be eligible to hold any office or position of trust or confidence in the organization until such time as the member has been reinstated by the Board of Directors.

5. The Board of Directors shall have the authority to discharge a member who has been found guilty of a crime involving moral turpitude, or any other crime that reflects adversely on the member's character or fitness to hold office in the organization.

6. A member who has been discharged from the organization shall not be eligible to hold any office or position of trust or confidence in the organization until such time as the member has been reinstated by the Board of Directors.

7. The Board of Directors shall have the authority to discharge a member who has been found guilty of a crime involving moral turpitude, or any other crime that reflects adversely on the member's character or fitness to hold office in the organization.
