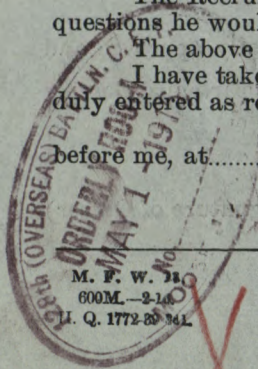
CERTIFICATE OF MAGISTRATE.

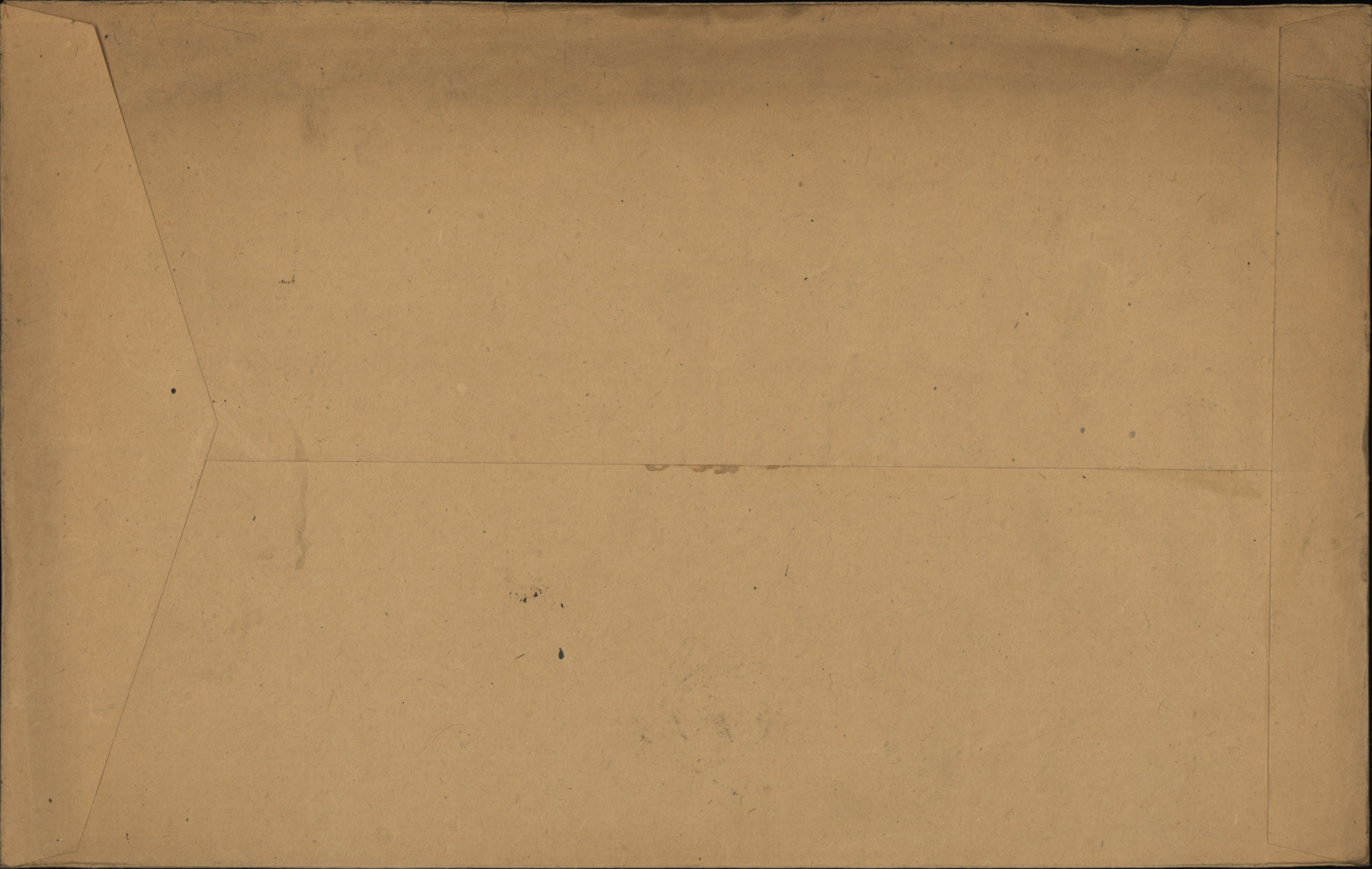

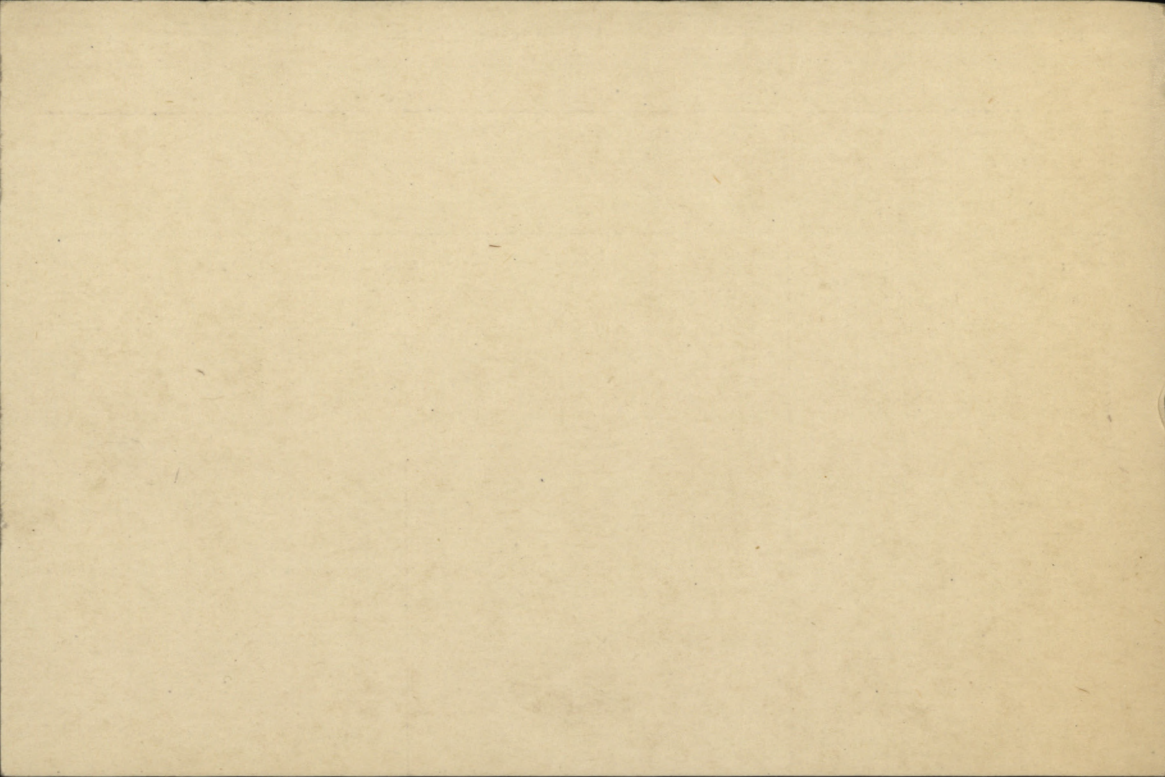
