The Stomach was much enlarged, contained an amount of pultaceous food and shewed evidences of Acute Gastritis.

The Intestines, Liver, Spleen and Pancreas were normal.

There was a Retro-Peritoneal haemorrhage on the right, the source of which could not be found.
