It pained him so he could not remain on duty. he reported his condition to the Medical Officer of his unit who had him report to the Military Hospital for treatment. Admitted to the Military Hospital on the morning of the 15-2-18. The nail of his big toe was about off and was removed by the Medical Officer in charge of Military Hospital.
