In Oct. 1916 in England he first noticed a slight enlargement in the neck over the Isthmus of the Thyroid glands which gradually spread over the right lobe. This increased in size and he developed nervous symptoms. In July 11-19 an operation was performed when the right lobe (which was found to be Cystic) and a portion of the Isthmus were removed. It has now completely healed. No disability due to nor aggravated by service.

CONDITION ON ADMISSION AND PROGRESS OF CASE. History:- The marginally noted soldier states that he first noticed a swelling on the lower and right side of the neck while in France about 18 months ago. This rapidly increased in size until it was as large as a hen's egg. He states that he was treated in Hospital overseas for this condition but without any benefit.

EXAM:- There is a tumor in the muscular triangle of the neck about the size of a small hen's egg. This is apparently confluent with the thyroid gland as it moves on deglutition. There is no exophthalmos, no tachycardia and no tremor. Patient complains of interference with respiration at times and of the inconvenience due to size and position of tumor.

DIAGNOSIS:- Parenchymatous and cystic tumor of the thyroid gland. Advise removal of right lobe of the thyroid.

OPERATION:- 11-7-19. Choicher incision. Thyroid gland exposed reveals a cyst of the lower pole of the right lobe associated with a general adenomitis condition of the entire right lobe. The right lobe and isthmus were completely excised except for a small amount of gland in the superior pole. Wound closed. Drainage tube placed in median line.

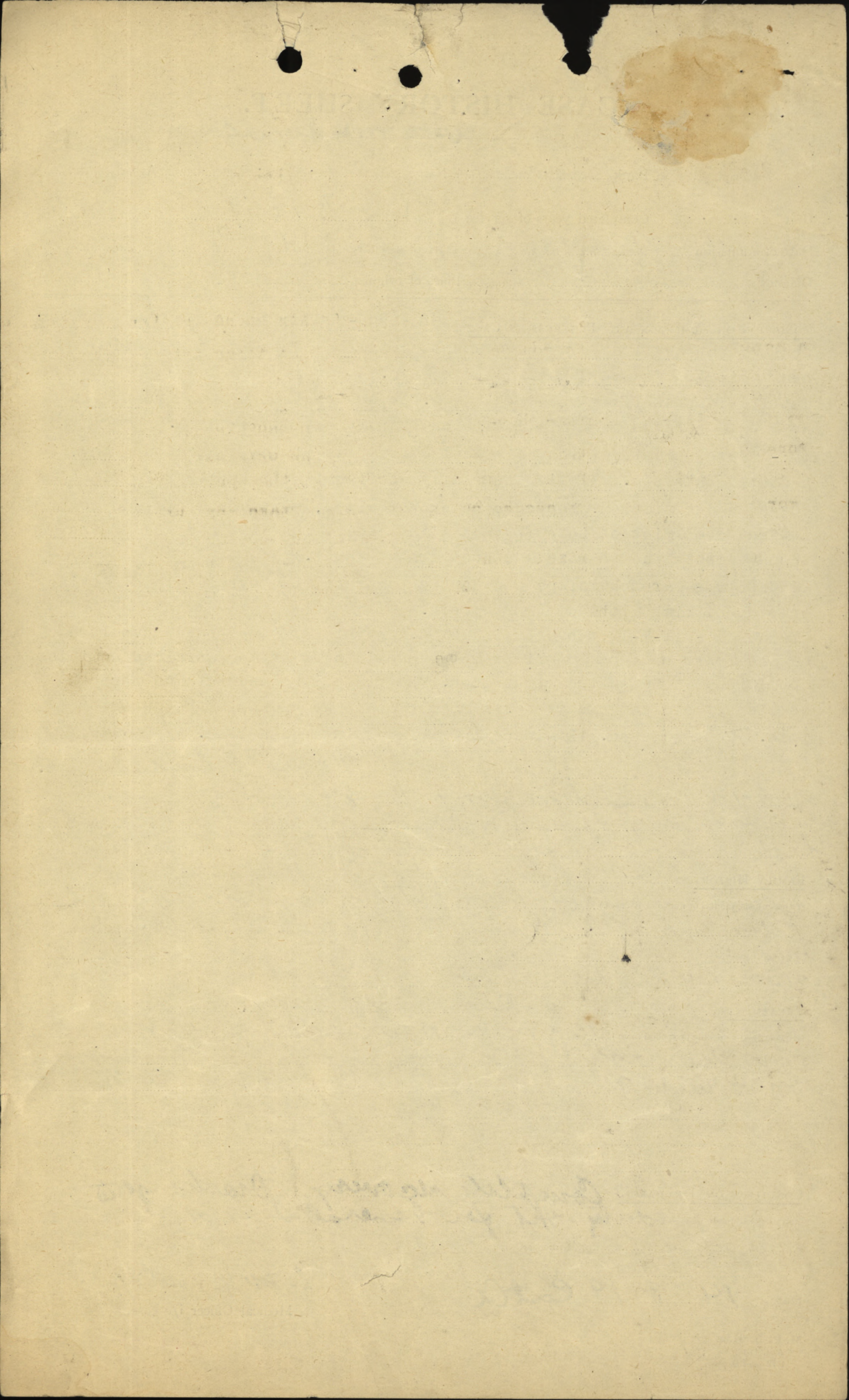

Since enlisting - had a slight attack of dysentery in Sept 1918. Went to Hosp in Jan. 1919 for Goitre.
Present trouble - commenced in Oct. 1916 with a small lump in front of neck, which began to be quite noticeable early in 1918 and he was obliged to open shirt-collars, and in Jan 1919 went to Hosp. on account of this swelling, and has been in Hosp. ever since.
Present condition - Patient says he feels very well - appetite and digestion are good - is fairly well nourished - there is an enlargement of thyroid in the centre and a little to the right about the size of a small hen's egg which appears to be cystic. Heart action is a little rapid and a rough 1st sound at apex. Chest is depressed over the stomach, a congenital condition. Chest-sounds are clear but some crackly respiration over left lung behind.
