Declaration by Margaret Louis (nee Hope)

Concerning her claim to participate in any grant to Half-Breeds who were residents on the 15th July, 1899, of that portion of the North-West Territories ceded by the Indians under treaty with the Government of Canada, at Peace River Crossing

1. What is your name and P. O. Address? Margaret Louis Peace River Crossing
2. Where and when were you born? at Lac La Piche about 1856
3. What was the name of your father? James Hope
4. What was the name of your mother before her marriage? Judith Desjarlais
5. Was your father a Half-Breed or an Indian? French Halfbreed
6. Was your Mother a Half-Breed or an Indian woman? French Halfbreed
7. Where have you been living each year since your birth? (if claimant was under 18 years of age on the 15th July, 1870, the place of residence of the parents at that date should also be ascertained) at Lac La Piche for 24 years, Lesser Slave Lake 10 years, Lake Selkirk two years and latterly at Peace River Crossing for 8 years
8. What has been your occupation? grass mow
9. If married, when, where and to whom? married at Lac la Piche in 1868 to Louis
10. How many children have you living? none
11. What are their names, dates of birth and names of birthplace?
12. What was the name of their respective mothers or fathers, as the case may be?
