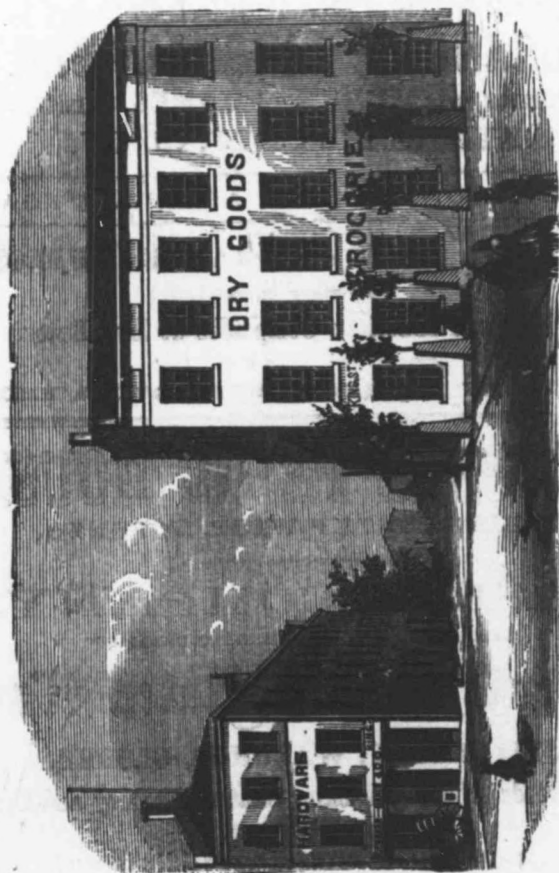

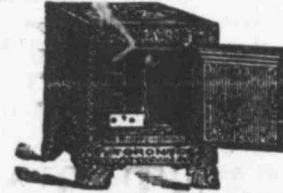

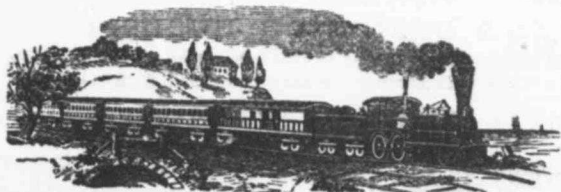

HAMILTON.

The city of Hamilton, as a point for the carrying on of a large wholesale trade, presents many advantages to the retail merchants of Western Canada that no other Canadian city can, Montreal or Toronto not excepted. The Hamilton importers can purchase in the English and other European markets equally as low as the Montreal importer, and can sell to the retailer equally as low, adding the freight from Montreal which is much lessened by the larger quantities taken by the importer than the usually small amounts carried for the retailer from Montreal. There is also a large saving in insurance, charges, &c. From the excellent facilities afforded for transportation of merchandize from Hamilton, the country merchant in almost any part of Western Canada, can, in forty-eight hours, get frequent supplies of such articles as he may want to keep his stock supplied, without being necessitated to take a trip to more distant markets, and to save expense be compelled to purchase largely and unfortunately too often beyond his means.

Hamilton may feel justly proud of its numerous large and wealthy wholesale establishments. In dry goods, groceries, hardware, crockery, clothing, drugs and medicines, fancy goods, hats and caps, leather and findings, iron and steel, jewellery, paper warehouses, saddlery hardware, wine and liquors, reference can be made to the full lists of names given under each branch of business in the classified departments of Hamilton in another part of this work.

In manufactures Hamilton is now rapidly striving to compete with her sister cities of Canada, and in mechanical industry to a large extent lies the prosperity, wealth and happiness of any community, but more particularly so of our large cities. Many capitalists are becoming alive to the importance of Hamilton as a manufacturing point, and some very extensive establishments, of new branches of trade, have been within two years commenced and carried on with excellent success.

The following is a brief review of the several establishments:

AGRICULTURAL IMPLEMENTS.—L. & P. Sawyer are exclusive manufacturers of agricultural implements. The works were established in 1834 by McQuesten & Co.; Messrs. Sawyer have been carrying on the works for about eight years; they give employment to thirty men, and use twenty-two horse steam power to propel their machinery; they turn out about thirty thousand dollars worth of threshing machines, mowers, reapers, and general machine work, per annum. There are several other firms manufacturing agricultural implements, but more largely engaged in general foundry and machine work. (See Foundries and Machine Shops.)

BELLOWS.—Dallyn & Sons are the only makers in the city, their shop is on James street, corner Stinson.

BOAT BUILDING.—The only person in this branch is Denis Phelan who employs generally three hands.

BOOTS AND SHOES.—The largest boot and shoe manufactory in Western Canada is here carried on by R. Nisbet & Co. It was established in 1860. They now give constant employment to one hundred and forty hands, turning out one hundred and twenty thousand pairs of boots and shoes per annum. They use a number of machines requiring a twelve horse power engine to propel. All the machinery is of American invention and make, and consists of three pegging machines, each of which will peg on an average sixty pairs of boots and shoes per hour, one rolling machine, a splitting machine, heel press, welt cutter, sole cutting machine, heel rounding machine, and a counter skiver. There are several other firms employing from five to ten hands.

BRICK MAKING.—Alfred Leittle and Daniel New are turning out each about one million and a half of bricks during the season; they employ each about twenty-five men.

BROOM MAKING.—There are three or four firms doing each a large business. In this branch of trade about fifty hands are kept employed.

BRUSH MANUFACTURING.—This branch of industry is carried on by Meakins & sons, King street east, who give constant employment to nine hands.—Alfred J. Green in the same branch employs four hands.

CARRIAGE AND COACH BUILDERS.—The Burlington Carriage fac-

tory, Macabe & Co., proprietors, is situated on King street west, near Caroline. They employ thirty men, and turn out 120 buggies, carriages &c., during the year. They manufacture coaches, carriages, buggies, sleighs, cutters, &c., of every description.

J. P. Pronguey, (City Coach Factory,) employs twenty hands and turns out about twenty-five thousand dollars worth of coaches, carriages, &c., per annum. Coaches from this establishment are sent to Toronto.

H. G. Cooper & Co. (Hamilton Coach Factory) employ fifty hands in various departments, and turn out in the carriage line twenty thousand dollars worth per annum. Many of these men are employed in spring making, silver plating and hame manufacturing.

THE CANADIAN OIL COMPANY employ from fifteen to twenty men, and turn out about one hundred and fifty barrels of refined oil per week. A capital of over fifty thousand dollars is invested in carrying on the establishment. The store is on King Street, West.

THE HAMILTON OIL COMPANY employ about ten men, and turn out about one hundred barrels per week. The warehouse is on James Street, near Post Office.

COFFEE AND SPICE MILLS.—Samuel Cann established works of this kind in 1859. He employs eight hands, and uses steam power to the extent of six horses. In broom making he gives employment to six hands, and manufactures broom handles.

CONFECTIONERY AND BISCUIT MANUFACTURING.—The principal establishments are that of J. C. Chilman, on King street, west; who employs sixteen hands. And that of Z. Pattison, on Cannon street, near Bay, who employs nineteen men in the manufacture of confectionery, biscuits, and cigars. W. T. Ecclestone, on King street, near James, employs a number of men in the manufacture of biscuits and confectionery.

COOPERAGES.—That of Wm. Woolley's, in the manufacture of cooper work, wooden bowls, tanks, &c., employs four hands and an engine of five horse power.

FURNITURE.—There are several shops; that of James Reid on King street, corner Bond, was established in 1841; twenty men are constantly kept employed, and twenty thousand dollars worth of cabinet work turned out per annum. Edgar & Melville, very extensive

manufacturers in this line as well as in sash, doors, blinds, hubs, spokes, felloes, &c., were unfortunately thrown out of business by the destruction of their premises by fire, in July last. Over 100 men were thrown out of employment. They are now making arrangements for the commencement of business in the same line again.

GRATES.—Nelson B. Robbins, on Mary street, near Wilson is exclusively engaged in the manufacture of grates and iron railings. The works were established in 1856—five men are kept employed, and \$8,000 worth turned out per annum.

CANADA FELT HAT WORKS.—This establishment commenced operations in 1859; they employ seventy hands, and a steam engine of twenty-five horse power. The firm uses 100,000 lbs. of wool, 500 cords of wood, 100 tons of coal, 10,000 skins, 100 barrels of alcohol; and turn out \$200,000 worth per annum. The average wages of the men are two dollars per day.

HOSE (fire).—The manufacturers in this line of business are Wm. Inkson and E. Kraft, they are also manufacturing saddles, harness, trunks, valises, &c., and employ each about nine hands.

IRON BEDSTEADS.—The only manufacturers are Sutherland & Deans, King street, between Bond and Bowery.

IRON FOUNDERS AND MACHINISTS.—E. & C. Gurney established their works in 1843; 70 hands are employed in this establishment, and an engine of twenty horse power used for propelling the machinery. They manufacture stoves, hollowware, tinware, and machine work of every description. Value of work turned out during the year, \$120,000.

D. MOORE & Co. employ forty hands; their works are on Catherine street, and were first established by E. Jackson in 1829—stoves, tinware, and machinery castings are turned out by this firm to the value of \$125,000 per annum.

THE MCNAB STREET FOUNDRY, carried on by J. Stewart & Co., was established in 1845. They employ forty men, and an engine of ten horse power—stoves, machinery, and general castings are made by them.

COPP & BROTHER, (Empire Foundry, Bay Street.)—The business was established in 1857, but during the present season they have erected large and substantial stone buildings on Bay street for the

foundry and machine shops—they give employment to forty hands, steam power thirteen horse.

MARY STREET FOUNDRY.—Turnbull & Co. established the foundry in 1845, employ twenty men, use an engine of 7 horse power, and turn out \$15,000 worth of machinery and castings per annum.

ENGINE BUILDERS AND BOILER MAKERS.—F. G. Beckett & Co. have a large establishment, founded in 1855; they employ forty hands, and use an engine of eighteen horse power. This firm turns out about forty steam engines and boilers, and other kinds of machinery per annum, to the value of \$30,000.

JOHN THOMAS, machinist, employs eleven hands and an engine of eight horse power.

GEORGE NORTHEY, engine builder and boiler maker, employs six hands, and an engine of ten horse power; turns out work to the value of eight thousand dollars per annum.

MARBLE WORKS.—Hurd & Roberts, established in 1852, employ eighteen hands, and turn out about \$25,000 worth of work per annum. Day & McComb, established in 1857, employ eight hands, and turn out about \$5,000 worth per annum.

MELODEON MANUFACTURER.—Thos. W. White, of James street north, is the only manufacturer; he employs several men, and the instruments turned out are considered to be of a superior quality and finish.

NAILS.—R. Juson & Co. carry on the manufacture of nails, spikes, and rivets, and employ ten men.

PIANO FORTES.—The Western Piano Forte Factory was established by Charles L. Thomas in 1856, who employs twenty-five men and turns out about seventy-five pianos per annum. The instruments manufactured here are of excellent finish, there being none but the best of workmen employed in the establishment.

POWDER.—The Hamilton Powder Co. have an office on James corner of Main street. The works are situated in the township of Nelson, county of Halton, 16 miles from Hamilton.

ROPE AND CORDAGE.—The Great Western Rope Works are situated on Mary street, corner Oak, and were established in 1854, and are now

carried on by Alex. Main & Co., who employ fourteen hands and turn out manufactured goods to the value of \$15,000 per annum.

SCALE WORKS.—The Provincial Scale Works established in 1856, by Gurney, Ware & Co., are situated on James opposite Bank of Upper Canada. They use twenty-five horse steam power; and give employment to fifteen men. Value of manufactures per annum, \$18,000.

SEWING MACHINES.—R. M. Wanzer & Co., James corner Vine, established their factory in 1861, since which time they have manufactured over six thousand four hundred machines, and are now manufacturing sixty machines a week. They use an engine of ten horse power, and employ about seventy hands. \$130,000 worth of machines are turned out annually.

SOAP AND CANDLES.—There are three firms, doing each a large business in this line, viz:—John Judd, Bay street; James Walker, Bowery, corner Main; and David Morton, East Avenue near King.

TOBACCO MANUFACTURERS.—The firms engaged in the manufacture of tobacco are A. P. Watson & Co., King Street West, employing about seventy hands; F. Schwarz, James street, employing forty hands; J. H. Hill & Co., John street, near King William, employing forty hands; and G. H. & H. A. King, Rebecca street, near John, who employ fifteen hands; Coventry & Co., York street, employ a number of hands.

CIGARS AND TOBACCO.—Chas. A. Birge, manufacturer and wholesale dealer in cigars and tobacco, employs five men making cigars and turns out of the establishment about twenty-five thousand dollars worth per annum.

VINEGAR WORKS.—The Hamilton Vinegar Works were established in 1845, by B. E. Charlton, corner King and Wellington; he employs four men, and turns out \$23,000 worth per annum. S. B. Medley, corner Peel and Walnut, is doing a good business in the same line.

HAMILTON GLASS WORKS.—These works have been lately established by Gatchell, Moore & Co. It is the only factory of the kind in Western Canada; and there is no doubt from the experience of some members of the firm, and the abundance of capital at command, that success will crown the enterprise; fifty hands will be kept in constant employment; flint and green glass, druggist's ware, soda

water bottles, &c., to the value of fifty thousand dollars per annum, will be turned out.

ROLLING MILL.—The Rolling Mill recently erected by the Great Western Railway Company, is 170 feet in length, 100 feet in width, 35 feet in height to the eaves, and running from thence to about 70 feet in the centre of the roof. The roof is formed of crossbeams; the engine foundation is of stone, 12 feet high, 16 feet wide, and 35 feet long, there are about 7000 cubic feet of stone in all. One engine of 400 horse power is used together with two smaller engines of twenty horse power each; there are three boilers two of which are thirty feet long and thirty inches in diameter, and one forty inches in diameter. The saws are four feet in diameter, and make 1000 revolutions per minute. The cooling bed is formed of an inclined plane, the large engine is a high pressure vertical engine, with twenty four inch cylinders, three feet stroke, and makes 60 revolutions per minute; the fly wheel is 24 feet in diameter, and weighs 35 tons; the small engines are horizontal, and have two cylinders each with a line 10½ inches in diameter, twenty inch stroke. To manufacture 4000 tons of new rails, will consume about 5000 tons of coal; the company employ about 150 men in this mill; and have four rail heating furnaces, and one double puddling furnace. The machinery for the mill was manufactured for the Railway Company by Goldie, McCulloch & Co., of the town of Galt, for the contract price of \$45,000.

COURT OF ERROR AND APPEAL.—Judges, Hon. Archibald McLean, President; Hon. Wm. H. Draper, C.B., Chief Justice of Upper Canada; Hon. P. M. M. S. Vankoughnet, D.C.L., Chancellor of Upper Canada; Hon. W. H. Blake; Hon. Wm. B. Richards, Chief Justice of the Common Pleas; Hon. J. C. P. Esten, Vice-Chancellor; Hon. John G. Spragge, Vice-Chancellor; Hon. John H. Hagarty, D.C.L., Judge of the Court of Queen's Bench; Hon. Joseph C. Morrison, do. do.; Hon. Adam Wilson, Judge of the Court of Common Pleas; Hon. John Wilson, do. do.; Clerk and Reporter, Alexander Grant.

This Court was constituted for the hearing of appeals in civil cases from the Courts of Queen's Bench, Chancery and Common Pleas, and appeals in criminal cases from the Courts of Queen's Bench and Common Pleas. From the judgment of the Court, an appeal lies to

Her Majesty in Privy Council, in cases over £1000, or where annual rent, fee, or future rights, of any amount, are affected. The Court sits three times a year.

COURT OF QUEEN'S BENCH.—Chief Justice, Hon. Wm. H. Draper, C.B.; Puisne Judges, Hon. J. H. Hagarty, D.C.L., and Hon. Jos. C. Morrison; Clerk of the Crown and Pleas, L. Heyden; Reporter, Christopher Robinson, Q.C.; Clerk in Chambers and Practice Court, William B. Heward; Clerk of the Process, Robert Stanton; Crier and Usher, Andrew Fleming.

The jurisdiction of this Court extends to all manner of actions, causes and suits, criminal and civil, real, personal and mixed, within Upper Canada; and it may proceed by such process and course as are provided by law, and as shall tend with justice and despatch to determine the same; and may hear and determine all issues of law, and also, with the inquest of twelve good and lawful men (except in cases otherwise provided for), try all issues of fact, and give judgment and award execution thereon, and also in matters which relate to the Queen's revenue (including the condemnation of contraband or smuggled goods), as may be done by Her Majesty's Superior Courts of Law in England.

COURT OF CHANCERY.—Chancellor, Hon. P. M. M. S. Vankoughnet, D.C.L.; Vice-Chancellors, Hon. James C. P. Esten; Hon. John G. Spragge; Master, Andrew N. Buell; Taxing Officer, George Hemings; Registrar and Reporter, Alexander Grant; Special Examiners, John Hector, Q.C., and William Vynne Bacon; Usher, John Oliver.

This Court has the like jurisdiction as the Court of Chancery in England in cases of fraud, accident, trusts, executors, administrators, co-partnerships, account, mortgages, awards, dower, infants, idiots, lunatics, and their estates, waste, specific performance, discovery, and to prevent multiplicity of suits, staying proceedings at law prosecuted against equity and good conscience, and may decree the issue, repeal or avoidance of letters patent, and generally the like powers as the Court of Chancery in England possesses to administer justice in all cases in which there is no adequate remedy at law.

COURT OF COMMON PLEAS.—Chief Justice, Hon. William B. Richards; Puisne Judges, Hon. Adam Wilson; Hon. John Wilson;

Clerk of the Crown and Pleas, M. B. Jackson; Reporter, S. J. Vankoughnet; Clerk of the Process, Robert Stanton; Crier and Usher, Daniel Connell.

This Court was established by the Act 12 vic. cap. 63. It consists of three Judges, who sit in Term, in the same manner as the Judges in the Queen's Bench, and has the same powers and jurisdiction as a Court of Record, as the Court of Queen's Bench. Writs of summons and *capias* issue alternately from each Court.

PRACTICE COURT AND CHAMBERS.—One of the Common Law Judges holds a Court during each Term, called the "Practice Court," for hearing matters relating to the adding or justifying bail, discharging insolvent debtors, administering oaths, hearing and determining matters on motion, and making rules and orders in causes, and business depending in either of the Law Courts. Chambers are held each day in Law and Chancery by one of the Judges of the Courts, for such business relating to suits therein as may be transacted by a single Judge out of Court. Clerk, Common Law, William B. Heward—Chancery, John Black.

HEIR AND DEVISEE COMMISSION.—Commissioners, the Judges of the Courts of Queen's Bench, Chancery, and Common Pleas, and such other persons as may be appointed by commission under the Great Seal.

Their duties are, to determine claims to lands in Upper Canada for which no patent has issued from the Crown in favour of the proper claimants, whether as heirs, devisees or assignees. Clerk, William B. Heward.

COUNTY COURTS.—Presided over by a resident Judge in each County. Their jurisdiction extends to all personal actions where the debt or damages claimed do not exceed £50; and to all suits relating to debt, covenant and contract, where the amount is liquidated or ascertained by the act of the parties or signature of the defendant, to £100; but not to cases involving the title to lands (with the exception of actions of ejectment in specified cases), validity of wills, or actions for libel, slander, crim. con. or seduction. An appeal lies to either of the superior Courts of law. These Courts also possess equity powers to the amount of £50, subject to an appeal to the Court of Chancery.

SURROGATE COURTS.—These Courts are now regulated by Con. Stat. U. C. cap. 16, and grant administration, subject to an appeal to the Court of Chancery. Clerk, Chas. Fitzgibbon, Toronto.

COURTS OF QUARTER SESSIONS.—Chairman, the County Judge in each County, who, with one or more Justices of the Peace, holds a Court of Quarter Sessions in his County four times a year, for trials by jury in cases of larceny, misdemeanour and other offences, and for the decision of appeals from summary convictions.

RECORDER'S COURTS.—In the Cities of Toronto, Hamilton, London, Kingston and Ottawa, the Recorder's Court takes the place of the County Sessions, the Justices for Counties having no jurisdiction in the Cities, the care of which is confided to the Recorder, Mayor, Aldermen and Police Magistrates of each.

INSOLVENT DEBTORS' COURTS.—The County Judge in each County presides.

DIVISION COURTS.—For the summary disposal of cases by a Judge; but a jury of five persons may be demanded in certain cases. Their jurisdiction extends to actions of debt or contract amounting to £25, injuries or torts to personal chattles amounting to £10, but not to actions for gambling debts, liquor drunk in a tavern, or notes of hand given therefor, ejectionment, title to land, &c., or any toll, custom or franchise will or settlement, malicious prosecution, libel, slander, crim. con., seduction or breach of promise, or actions against a J. P. for anything done by him in the execution of his office, if he objects to it. Courts are held once in two months in each Division, or oftener, at the discretion of the Judge. The Divisions are established by the Courts of Quarter Sessions.

CLERKS OF ASSIZE.—Clerks of Assize, the Deputy Clerks of the Crown are *ex officio* Clerks of Assize and Marshals in their respective Counties. In the Home Counties the Chief Clerks of the two Courts officiate alternately. W. Campbell, Clerk of Assize.

DEPUTY CLERKS OF THE CROWN.—The Clerks of the County Courts will be *ex officio* Deputy Clerks of the Crown and Pleas of their

several Counties, as the present incumbents vacate by death or otherwise.

DEPUTY MASTERS AND REGISTRARS IN CHANCERY.—These officers are appointed by the Court for each County, as occasion requires.

CLERK OF THE PROCESS.—For sealing and issuing (alternately) all writs of summons in the Queen's Bench and Common Pleas—Robert Stanton. The Deputy Clerks of the Crown in the several Counties also, in like manner, issue the writs for their respective Counties.

CIRCUITS OF THE COURTS.

LAW CIRCUITS.—The Circuits are held twice a year in each County, between Hilary and Easter Terms, and between Trinity and Michaelmas Terms, except in the City of Toronto and united Counties of York and Peel, where there are three in each year.

CITY GOVERNMENT, 1864.

Hamilton was incorporated a city on the 1st of January, 1847. It is divided into five wards, which are bounded as follows: St. Lawrence Ward is bounded on the north by Burlington Bay, on the east by city limits, on the south by King street, and on the west by John street; St. Patrick's Ward, on the north by King street, on the east by city limits, on the south by the mountain, and on the west by John street; St. George's Ward, on the north by King street, on the east by John street, on the south by the mountain, and on the west by city limits; St. Andrew's Ward, on the north by Burlington Bay, on the east by John street, on the south by King street, and on the west by McNab street; St. Mary's Ward, on the north by Burlington Bay, on the east by McNab street, on the south by King street, and on the west by city limits.

The common Council, which is elected annually on the first Monday in January, is composed of twenty members, two Aldermen, and two Councillors for each Ward.

By a recent enactment, the Inspectors of License, who have heretofore been elected by the people, are chosen by the Common Council.

GRAMMAR SCHOOL.—The Senior County Grammar School is at present conducted in the Central School buildings. Its Trustees are six in number. Head Master, J. M. Buchan, B.A.; Mathematical do., James B. Grey, Esq.

CENTRAL SCHOOL.—Archibald Macallum, Esq., B.A., Principal.—This school was established in 1853, has twenty-one teachers, and an average attendance of 1100 pupils. Sessions commence first Mondays in January and August. The course of instruction includes reading, writing, arithmetic, geography, grammar, history, (Canadian, English and general), linear drawing, book-keeping, human physiology, astronomy, elements of natural philosophy and chemistry, algebra, Euclid, mensuration, and trigonometry, natural history, botany, and geology, and the Latin, Greek and French languages. The charge is a monthly fee of twenty-five cents, for which, besides tuition, all books, stationery, &c., are provided. In the grammar school department the fees are \$3 per term, and the pupils supply themselves with classical books. Any person desiring it, can remain at the school till prepared for entering the University. In connection with the Central are six Primary or Ward schools, all under the immediate charge and direction of the Principal, assisted by 34 teachers. There is a library in connection with the school, containing 1,800 volumes, to which the pupils have free access.

ROMAN CATHOLIC SCHOOLS.—There are two separate schools in Hamilton, under the control of the Roman Catholic Church, one in St. Mary's, the other in St. Patrick's Ward. Teachers in Park street school, Miss Grace Magan, Miss Teauxbury, Miss Magan and Mrs. Curtis. Number of pupils 264. Teachers in Peel street school, Mr. Shea, Miss M. Magan, and Miss Bingham. Number of pupils 246. Sum total of pupils in the schools: Sisters' school, 55; Orphans, 65; Peel street, 246; Park street, 264; total, 630. Besides the above there are two or more private or select Catholic schools in the city.

For the academic year, for all the Preparatory department, with board and washing, including Music or French and Drawing, the amount will be \$175,00; without Music or other extras, it will be \$142,00. The expenses are, of course, graduated according to the number of extra studies taken during the year.

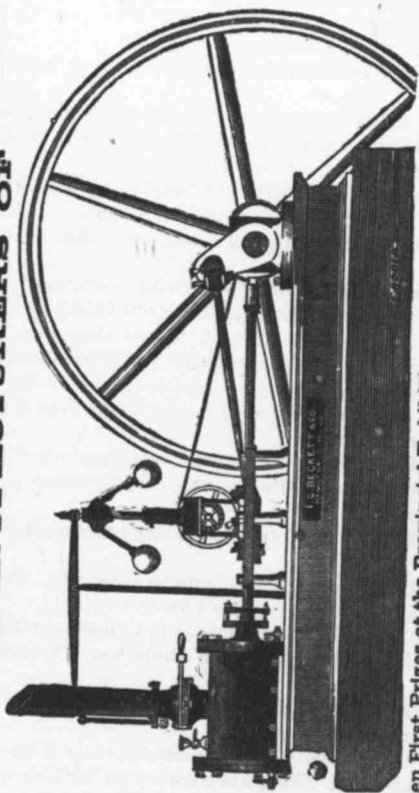

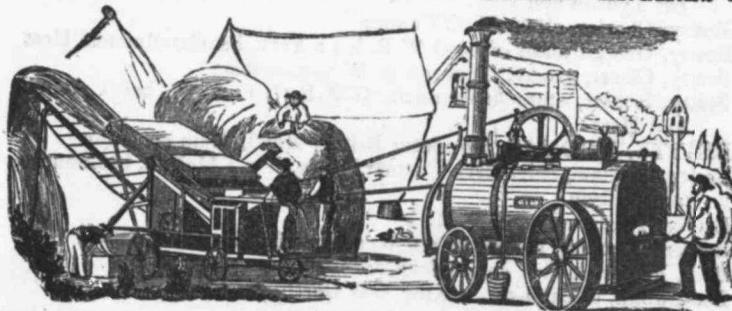
